## ORDER

The Ministry of Environment & Forests, (MoEF), Government of India, has issued Environmental Clearance to the Vizhinjam International Deep water Multipurpose Seaport Project based on the Environment and Social Impact Assessment (ESIA) study report prepared through M/s L&T Ramboll Consulting Engineers Ltd. As per the ESIA report, the Project Affected Persons have been identified in the following two categories namely (i) those affected by loss of land due to land acquisition and (ii) those affected due to loss of livelihood.

The package for Project Affected Persons who is affected due to loss of land (first category) has already been fixed and compensated as part of the land acquisition process. The ESIA report has given an estimate of the second category (ie. whose livelihood is affected) along with a compensation package.

Accordingly, the Managing Director, Vizhinjam International Seaport Ltd in his letter read above has requested to constitute Livelihood Impact Appraisal Committee for the purpose. In the meeting convened by the Hon. Minister (Ports) held on 07-07-2015 it was decided to constitute the Livelihood Impact Appraisal Committee and Appellate committee to Livelihood Impact Appraisal Committee.

In the circumstance, Government are pleased to constitute Livelihood Impact Appraisal Committee with the following members for appraisal and identification of the persons affected by the development of Vizhinjam International Deep water Multipurpose Seaport Project.
