ORDER

As per Government Order read as first paper above, Government has approved the bid submitted by M/s Adani Ports & Special Economic Zone Ltd seeking a grant of Rs 1635 crores for implementing Vizhinjam International Deep water Multipurpose Seaport project. Further, Government of Kerala has signed Concession Agreement with M/s Adani Vizhinjam Port Private Ltd on 17-08-2015.

Before starting the project, rehabilitation of those who have incurred loss/ damages in connection with the implementation of the project has to be settled. A Livelihood Impact Appraisal Committee under the Revenue Divisional Officer to find out the affected persons and to ascertain the compensation they are entitled to and an Appellate Committee under the District Collector, Trivandrum has been constituted as per the Government Order read as second paper above.

Traditional fishermen who go to sea in small boats and catamarans to catch fish from the project area, those who are engaged in shore seine fishing, mussel / oxster collectors / catchers in the project area are directly affected by the were venture of the see using here. venture to the sea using boats fitted with engines at the time of the construction of the project. In addition, those who are making their livelihood by selling fish and

who are working in the resorts situated in the area acquired for the project and those in the project area are indirectly affected.

According to the Environment and Social Impact Assessment Report and assessment, by the Ministry of Environment & Forest, construction of the port would not be a reason for shore line(coastal depletion) changes. However, in the circumstance of anxieties of coastal depletion due to the construction of the project, Government have to give assurance regarding the compensation and rehabilitation of those affected if coastal depletion occurs in future. Government have to acquire 50 acres of land in five years at different places and include the land in the land bank scheme for the implementation of various projects by the State Fisheries department. There exists an issue of homelessness even now in coastal areas. If coastal area depletion occurs, flats for those affected will have to be constructed for them, in the above mentioned land under this scheme.

Other anxieties being raised include substantial reduction of fish catch and accidents that may occur. Up gradation of schools, enhancement of the Primary Health centers, Establishment of Technical Educational Institutions, Skill Up gradation centre, Marine Academy, etc are also matters that need to be considered.

In this circumstance, Director of Fisheries has submitted a draft project to Government amounting to Rs 475 crores which includes strengthening of deep sea fishing facilities and its associated training, forming of voluntary helping groups, setting up of security systems, Empowerment of women, improvement in educational facilities, health facilities, welfare measures for the old.

Government have examined the project submitted by the Director of Fisheries in detail and are pleased to issue orders sanctioning and approving the enclosed draft project amounting to Rs 475 crores to be expended in 5 years towards mitigating the anxieties raised in connection with the construction and implementation of Vizhinjam Sea port Project.
